**The rates will be for each person over the age of ten (10) years, payable in advance. No refunds will be granted.**

**Period of Issuance:** The period can be no more than nine (9) days with no more than three (3) days spent at any one campsite on the Arolik River. This permit must be in User's possession at all times and be produced for inspection upon request.

By signing this Permit Application, Applicant agrees to comply with the following terms and conditions, and this Permit is issued subject to such compliance:

1. Applicant understands that this Permit grants temporary access to land which is privately owned by Qanirtuuq, Inc., the Native Village Corporation for the village of Quinhagak; it does not grant access to individual Native allotment land.
2. Applicant acknowledges that use of the land is a privilege and User agrees that failure to observe federal, state, or local laws or regulations, interference with customs and rights of local residents, interference with local fishermen or fish camps, failure to exercise due care in use of the land, or violation of any other term or condition stated herein shall cause immediate and automatic revocation of this permit and will be grounds for refusing to issue a permit in the future.
3. If fresh caught fish dies, it has to be kept or given to another person that wants it. No dead fish put back in the water or on sandbars.
4. No alcohol beverages or illegal drugs on Qanirtuuq, Inc. lands.
5. Applicant agrees to indemnify and hold Qanirtuuq, Inc., its agents, employees, officers and shareholder harmless from any and all expenses, costs, and damages arising from, or as the result of, any action or suit of any kind that may be brought against Qanirtuuq, Inc. by any person or persons on account of granting or giving the User the privileges provided in this Permit. Applicant for him/herself and his/her children hereby releases and discharges any and all liability, and waives any and all claims, against the Qanirtuuq, Inc. its agents, employees, officers, and shareholders from damage to the User's property or injury to him/herself and/or children however the same shall occur or be caused, while using the land. Applicant recognizes that fishing, camping, hiking and boating can be dangerous activities and assumes those risks.
6. This permit is issued for temporary recreational use only, and Applicant agrees that the land will not be used for any commercial purpose, including mining, hunting, trapping or shooting (unless otherwise authorized in writing by a corporate officer).
7. Use of firearms is prohibited unless Applicant has received express permission is written on this permit by an officer of the Qanirtuuq, Inc.
8. Applicant agrees to confine camping activities to the nine (3) camping areas on the Arolik River.
9. Before leaving Qanirtuuq, Inc. land, Applicant agrees to properly dispose of all trash, litter, and human waste at approved receptacles and to leave the area in the same condition as when first arrived. No trash or fish will be buried in the area.
10. Applicant agrees to be out of the area not later than the expiration date shown above.
